## Payment Plans

There are two convenient ways to pay for your insurance policy.

### One Time Payment

You may pay the full policy premium with your application for insurance. Simply provide a cheque payable to KINGSWAY GENERAL INSURANCE COMPANY for the full policy premium quoted by your broker plus applicable provincial sales tax or complete the Credit Card Information section of our Payment Authorization form. Your cheque must be dated no later than the effective date of your policy.

If you are paying by cheque, you will receive an invoice for any additional amount that may be payable due to a difference between the quoted premium and our authorized prices. If you are paying by credit card, we will debit your credit card for the actual full policy premium.

You will receive an invoice for any additional amount that may be payable for subsequent amendments to your insurance coverage. Additional premium charges may be paid by cheque or VISA or MasterCard credit card.

There is no administration charge for this payment plan.

### Pre-Authorized Debit

With pre-authorized debit you can pay your insurance premium through automatic withdrawals from your bank account. Pre-authorized debit is available for six-month and twelve-month term policies. To take advantage of the pre-authorized debit plan, complete and sign the Payment Authorization form. Attach a blank "VOID" cheque from your bank account. If you wish to make your down payment by credit card, please complete the Credit Card Information section of the Payment Authorization form as well.

#### Other Than Motorcycle

New customers must provide a down payment equal to two instalments. The down payment may be charged to your VISA or MasterCard credit card or made by cheque payable to KINGSWAY GENERAL INSURANCE COMPANY.

The first automatic withdrawal is made in the second month of the policy term. The remaining withdrawals will be divided evenly over the policy term with the last withdrawal occurring in the second last month of the policy term. Any additional or return premium that may result from a subsequent amendment to your insurance coverage is spread equally over the remaining automatic withdrawals. On renewal of your policy, the first withdrawal will occur in the month prior to the effective date of your policy and will reflect your renewal premium. An administration fee is added to each instalment.

#### Motorcycle

Because of the seasonal use of motorcycles, policy premiums are paid in four instalments. New customers must provide a downpayment equal to one instalment. The down payment may be charged to your VISA or MasterCard credit card or made by cheque payable to KINGSWAY GENERAL INSURANCE COMPANY.

Automatic withdrawals are made thirty, sixty and ninety days from the policy effective date. An administration fee is added to each instalment.
