AXA Insurance offers a number of flexible and convenient payment plan options for your Personal Automobile and Property policies. Just choose the plan that works best with your budgeting and call your Broker to make the arrangements for your AXA policy.

1, 2 & 4 Payment Plans

One Payment

Pay your full policy premium at the beginning of your policy term.

Two Payments*

Split your premium in half and pay 50% at the start of the policy term and the balance as follows:

- in 90 days for a 1 year policy
- in 12 months for a 2 year policy

Four Payments*

Pay your policy premium in four easy, equal instalments.

Monthly Automatic Withdrawal
